



Federal Subcontract Solutions LLC (FedSubk) Terms and Conditions of Use:

THESE TERMS OF USE constitute an agreement ("Agreement") made between Federal Subcontract Solutions LLC ("FEDSUBK") and any person accessing FEDSUBK's website ("You") with respect to Your use of FEDSUBK's website(s) (the "Site"). Section 12: Miscellaneous

Independent Contractors. The parties and their respective personnel are and shall be independent contractors and neither party by virtue of this Agreement shall have any right, power or authority to act or create any obligation, express or implied, on behalf of the other party.

Waiver. No waiver of any term, provision or condition of this Agreement, whether by conduct or otherwise, in any one or more instances, shall be deemed to be, or shall constitute, a waiver of any other term, provision or condition hereof, whether or not similar, nor shall such waiver constitute a continuing waiver of any such term, provision or condition hereof. No waiver shall be binding unless executed in writing by the party making the waiver.

Severability. If any provision of this Agreement is determined to be illegal or unenforceable, then such provision will be enforced to the maximum extent possible and the other provisions will remain fully effective and enforceable.

Notice. Except as provided in Section 10 above regarding notices under the DMCA, all notices shall be in writing and shall be deemed to be delivered when sent by e-mail to either parties' last known e-mail address. You hereby consent to notice by e-mail. Notwithstanding the foregoing, you may remove your name and e-mail address from any correspondence sent by FEDSUBK by notifying FEDSUBK in writing that you are opting out of any future correspondence from FEDSUBK. All e-mail addresses obtained by FEDSUBK through this Site will be treated strictly in accordance with the FEDSUBK's Privacy Policy.

Law. This Agreement shall be governed by applicable federal law.



Forum. To the extent permissible under applicable law, all actions, claims or disputes arising under or relating to this Agreement shall be brought in a federal court in the State of Oklahoma. The parties irrevocably submit and consent to the exercise of subject matter jurisdiction and personal jurisdiction over each of the parties by a federal state court in the State of Oklahoma. The parties hereby irrevocably waive any and all objections which any party may now or hereafter have to the exercise of personal and subject matter jurisdiction by a federal court in the State of Oklahoma and to the laying of venue of any such suit, action or proceeding brought in any such federal court in the State of Oklahoma. When the end user is an instrumentality of the US Government, the following shall apply: This is a contract with the US Government and is subject to the Federal Acquisition Regulation. Venue and jurisdiction of any disputes are determined by the applicable federal statute (federal tort claims act, contract disputes act, etc.).

Process. The parties irrevocably submit and consent, and irrevocably waive any and all objections which any party may now or hereafter have, to process being served in any such suit, action or proceeding referred to in the preceding subsection pursuant to the rules of the applicable court, including, without limitation, service by certified or registered mail, return receipt requested. No provision of this Section shall affect the right of any party to serve process in any manner permitted by law or limit the right of any party to bring suits, actions or proceedings to enforce in any lawful manner a judgment issued by a federal court of the State of Oklahoma.

Headings. The captions and headings of this Agreement are included for ease of reference only and will be disregarded in interpreting or construing this Agreement.

Force Majeure. If the performance of any part of this Agreement by either party is prevented, hindered, delayed or otherwise made impracticable by reason of any flood, riot, fire, judicial or governmental action in its respective sovereign capacity, acts of war, terror, civil unrest, labor disputes, acts of God or any other causes beyond the control of either party, that party shall be excused from such to the extent that it is prevented, hindered or delayed by such causes.

Survival. The terms and provisions of Sections 1, 2, 3, 4, 6, 7, 8, 9, 10, and 11 shall survive any termination or expiration of this Agreement.

Entire Agreement. Any contract under which You enter with FEDSUBK expressly incorporates the Subscription Agreement and the Terms of Use of FEDSUBK's web site. Acceptance thereof is FEDSUBK's condition to providing Subscriber and its Authorized Users access to the site and service.
